

**SCOTIABANK LITTLE 13<sup>th</sup> MAN CONTEST**  
June 26, 2008 – October 10, 2008  
Official Contest Rules and Regulations – Page 1-6

**1. THE CONTEST:**

From June 26, 2008 to October 10, 2008 Scotiabank and the Saskatchewan Roughriders Football Club Inc. (The Club) ("Sponsors") offer children between the ages of seven and twelve the opportunity to win one of eight (8) prizes by participating in the "Scotiabank Little 13<sup>th</sup> Man Promotion". The Contest begins at 10:00 a.m. Mountain Daylight Time ("MDT") on June 26, 2008 and ends at 12:00 p.m. MDT on October 10, 2008 (the "Contest Period") after which time the Contest will be closed and no further entries shall be accepted.

**2. HOW TO ENTER**

- (a) No purchase necessary to enter the Contest. Enter using any of the methods of entry outlined below. No entries will be accepted by any other means.
- (b) Enter in person, complete the nomination form and drop it off at any participating Saskatchewan Scotiabank location during regular business hours: Carrot River, Glaslyn, Hudson Bay, Humboldt, Kinistino, Melfort, Nipawin, North Battleford, Prince Albert, Saskatoon CBC, 33<sup>rd</sup> St. and Ave C. 8<sup>th</sup> & Clarence, Centre East, Circle & Faithful, Lawson Heights, Midtown Plaza, Stonegate, Westside, Westgate, Shellbrook, Spiritwood, Tisdale, Wynyard, Avonlea, Beechy, Estevan, Kindersley, Moose Jaw, Moosomin, Outlook, Regina CBC, 13<sup>th</sup> & Robinson, Albert & 9<sup>th</sup>, Albert & Dewdney, Regent Park, South Albert, University & Quance, Rosetown, Swift Current, Weyburn, Yorkton.
- (i) To enter the "Scotiabank Little 13<sup>th</sup> Man Contest" your entry must be received by the Scotiabank branch by October 10, 2008 at 12:00 p.m. MDT.
- (c) Limit of one (1) entry per person during the Contest Period. In the case of multiple entries, only the first eligible entry will be considered.
- (d) All entries become the sole property of Scotiabank and none will be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. No communication or correspondence will be exchanged with entrants except with those selected for a Prize.

### 3. PRIZES.

- (a) There are eight (8) Prizes (each, a "Prize") available to be won by the Winners (each, a "Prize Winner"). Each Prize consists of four (4) tickets to a Saskatchewan Roughriders home game (date of game to be designated by the Sponsors), a replica jersey, winner will be introduced out of the player tunnel LIVE on the MaxTron, stand with the Alumni of the Game during all pre-game ceremonies, including the coin toss area at centre field and other recognition as determined by sponsors of contest.
- (b) Each Prize has an approximate value of three hundred dollars (CDN \$300).
- (c) Winner is not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
- (d) Prizes will be distributed within ninety (90) days after each Winner has been successfully contacted and notified of his/her Prize and fulfilled the requirements set out herein.
- (e) Prize Winner must be available to attend the Saskatchewan Roughriders game on the date designated by the Sponsors. Should Prize Winner be unable to attend on the dates and times designated by the Sponsors, the Prize will be forfeited and awarded to an alternate winner. Prize Winner will be responsible for: transportation to and from Mosaic Stadium, parking, food, taxes, gratuities, and any other expense not explicitly included in the Prize.
- (f) Prizes must be accepted as awarded and cannot be transferred, assigned, substituted or redeemed for cash, except at the sole discretion of the Sponsors. Any unused portion of a Prize will be forfeited and have no cash value. The Sponsors reserve the right, in its and their sole discretion, to substitute a prize of equal or greater value if a Prize (or any portion thereof) cannot be awarded for any reason.

### 4. WINNER SELECTION.

Eight (8) Winners shall be selected as follows:

- (a) On each "Selection Date", the sponsor will select the number of eligible entrants, corresponding to the number of prizes to be won (set out below) related to each Selection Date from all eligible entries ("eligible entries" referring to entries submitted prior to or on the Cut-off Date) in accordance

with these Official Rules. The Cut-off Dates are as indicated in the list below. The three (3) planned Selection Dates, the Cut-off date applicable to each Selection Date, and the numbers of prizes available to be won related to each Selection date are:

Selection Date: July 14, 2008. Three (3) Prizes are available to be won  
Game Days: July 19, July 27, August 7.  
Cut-off date: July 10, 2008 at Noon (MDT).

Selection Date: August 26, 2008. Three (3) Prizes are available to be won  
Game Days: August 31, September 20, October 3.  
Cut-off date: August 22, 2008 at Noon (MDT).

Selection Date: October 14, 2008. Two (2) Prizes are available to be won  
Game Days: October 19, October 25.  
Cut-off date: October 10, 2008 at Noon (MDT).

- (b) The contest is open to children between seven and twelve years old. Entrants must enter the contest with a parent or legal guardian and be a resident of Saskatchewan.
- (c) Contest is not open to employees and representatives of Scotiabank, the Saskatchewan Roughriders Football Club Inc. (The Club), and their advertising & promotional agencies and persons with whom they are domiciled. The contest is also not open to the judges and members of their immediate families with whom any of the foregoing are domiciled. For the purpose of these Contest Rules, "immediate family" means husband, wife, spouse, mother, father, brother, sister, son, daughter, whether or not they reside in the same household. Sponsors shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof within a reasonable period of time may result in disqualification. All personal and other information requested by and supplied to Sponsors for the purpose of this Contest must be truthful, complete, accurate and in no way misleading. Sponsors reserve the right to disqualify any entry or Entrant in its sole discretion, should any entry or entrant at any stage supply untruthful, incomplete, inaccurate or misleading personal details and/or information.
- (d) Each entrant shall be eligible to win only one (1) Prize. The odds of being selected for a prize depend on the extent to which eligible entries meet the judging criteria. Before being declared a Winner, the selected entrant shall be required to comply with the Contest Rules and sign and return the Release (described below).

- (e) If the parent/legal guardian of the potential winner cannot be reached within two days of the first telephone call made to them, their prize will be forfeited and another entrant will be drawn. The Sponsors are not responsible for a selected eligible entrant's failure to receive notification for any reason whatsoever. All entries become the property of Scotiabank and none will be returned.
  - (f) If, as a result of an error relating to the entry process, drawing or any other aspect of the Contest, there are more selected entrants than contemplated in these Contest Rules, there will be a random draw amongst all eligible Prize claimants after the Contest's closing date to award the correct number of Prizes.
5. **RELEASE.** Winner(s) will be required to execute a legal agreement and release ("Release") that confirms Winner's: (i) eligibility for the Contest and compliance with these Contest Rules; (ii) acceptance of the Prize as offered; (iii) release of each of the Sponsors and their respective parent companies, subsidiaries, affiliates and/or related companies and each of their employees, directors, officers, suppliers, agents, sponsors, administrators, licensees, representatives, advertising, media buying and promotional agencies (collectively, the "Releasees") from any and all liability for any loss, harm, damages, cost or expense arising out of participation in the Contest, participation in any Contest-related activity or the acceptance, use, or misuse of any Prize, including but not limited to costs, injuries, losses related to personal injuries, death, damage to, loss or destruction of property, rights of publicity or privacy, defamation, or portrayal in a false light, or from any and all claims of third parties arising therefrom; and (iv) grant to the Sponsors of the unrestricted right, in the Sponsors' collective or individual discretion, to produce, reproduce, publish, reproduce, convert, broadcast, communicate by telecommunication, exhibit, distribute, translate, adapt and otherwise use and re-use the Work and Winner's name, photograph, likeness, voice and biography in any and all media now known or hereafter devised, in connection with the Contest and the promotion and exploitation thereof. The executed Release must be returned within two (2) business days of the verification as a Winner or the selected entrant will be disqualified and the Prize forfeited.
6. **INDEMNIFICATION BY ENTRANT.** By entering the Contest, entrant releases and holds Releasees harmless from any and all liability for any injuries, loss or damage of any kind to the entrant, Releasees or any other person, including personal injury, death, or property damage, resulting in whole or in part, directly or indirectly, from acceptance, possession, use or misuse of any prize, participation in this Contest, any breach of these Contest Rules, or in any prize-related activity. The entrant agrees to fully indemnify Releasees from any and all claims by third parties relating to the Contest, without limitation.
7. **LIMITATION OF LIABILITY.** The Sponsors assume no responsibility or liability for lost, late, unintelligible/illegible, falsified, damaged, misdirected or incomplete

entries, notifications, responses, replies or any Release, or for any computer, online, software, telephone, hardware or technical malfunctions that may occur, including but not limited to malfunctions that may affect the transmission or non-transmission of an entry. The Sponsors are not responsible for any incorrect or inaccurate information, whether caused by website users or by any of the equipment or programming associated with or utilized in the Contest or by any technical or human error which may occur in the administration of the Contest. The Sponsors assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries. The Sponsors are not responsible for any problems, failures or technical malfunction of any telephone network or lines, computer online systems, servers, providers, computer equipment, software, e-mail, players, or browsers, on account of technical problems or traffic congestion on the Internet, at any website, or on account of any combination of the foregoing. The Sponsors are not responsible for any injury or damage to entrant or to any computer related to or resulting from participating or downloading materials in this Contest. Entrant assumes liability for injuries caused or claimed to be caused by participating in the Contest, or by the acceptance, possession, use of, or failure to receive any Prize. The Sponsors assume no responsibility or liability in the event that the Contest cannot be conducted as planned for any reason, including those reasons beyond the control of the Sponsors, such as infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or corruption of the administration, security, fairness, integrity or proper conduct of this Contest.

- 8. CONDUCT.** By participating in the Contest, each entrant agrees to be bound by the Contest Rules, which will be made available at all participating Scotiabank branches and on the Saskatchewan Roughriders Football Club Inc. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant found to be: (a) violating the Contest Rules; (b) tampering or attempting to tamper with the entry process or the operation of the Contest; (c) violating the terms of service, conditions or use and/or general rules or guidelines; and/or (d) acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. 9. **PRIVACY.** By participating in the Contest, entrant (a) grants to the Sponsors the right to use his/her name, mailing address, telephone number, and e-mail address (“Personal Information”) for the purpose of administering the Contest, including but not limited to contacting and announcing the Winners; (b) grants to the Sponsors the right to use his/her Personal Information for publicity and promotional purposes relating to the Contest, in any and all media now known or hereafter devised, without further compensation unless prohibited by law; (c) for the purposes of sending you information about the Sponsors’ products and/or services, and contacting you about future sales and marketing promotions and (d) acknowledges that the Sponsors may disclose his/her Personal Information to third-party agents and service providers of any of the Sponsors in connection with any of the activities listed in (a), (b) and (c) above.
10. **INTELLECTUAL PROPERTY.** All intellectual property, including but not limited to trade-marks, trade names, logos, designs, promotional materials, web pages, source code, drawings, illustrations, slogans and representations are owned by the Sponsors and/or their affiliates. All rights are reserved. Unauthorized copying or use of any copyrighted material or intellectual property without the express written consent of its owner is strictly prohibited. Scotiabank and the Saskatchewan Roughriders Football Club Inc. (The Club) are registered trademarks used under licence.
11. **TERMINATION.** Sponsors reserve the right, in their sole discretion, to terminate the Contest, in whole or in part, and/or modify, amend or suspend the Contest, and/or the Contest Rules in any way, at any time, for any reason without prior notice.
12. **LAW.** These are official Contest Rules. This Contest is subject to applicable federal, provincial and municipal laws and regulations. These Contest Rules are subject to change without notice in order to comply with any applicable federal, provincial and municipal laws or the policy of any other entity having jurisdiction over the Sponsors. All issues and questions concerning the construction, validity, interpretation and enforceability of the Contest Rules or the rights and obligations as between the entrant and the Sponsors in connection with the Contest shall be governed by and construed in accordance with the laws of the province of Ontario including procedural provisions without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction’s laws.
13. **LANGUAGE DISCREPANCY.** In the event of any discrepancy or inconsistency between the terms and conditions of the Contest Rules and disclosures or other statements contained in any Contest-related materials, including but not limited to the Contest entry form, or point of sale, television, print or online advertising, the terms and conditions of the Contest Rules shall prevail, govern and control.
